- a) Bidders must hold valid CIDA registration as specified in the table above.
 - b) Bidders must not be blacklisted.
 - c) Minimum liquid assets/credit facilities must be at least **30%** of the bid amount.
 - d) Bidders must demonstrate experience in at least one similar building project completed within the last three years.
2. All interested parties must be registered under Public Contract No. 3 of 1987 with the Department of the Registrar of Companies before collecting the Procurement Documents for the work "Extension of office Building at divisional secretariat of Pottuvil.
 3. Interested Bidders may obtain further information from the **Chief Accountant, District Secretariat, Ampara** and inspect the Procurement Documents at the address given below from 9.00 hrs. to 15.00 hrs. on working days from **24.04.2026 to 11.05.2026**

A complete set of Procurement Documents in English language may be purchased by interested Bidders on the submission of a written application to the **Chief Accountant, District Secretariat, Ampara from 24.04.2026 to 11.05.2026 from 09.00 hrs. to 15.00 hrs.** Upon payment of a non-refundable fee as mentioned above. The method of payment will be Cash.
 5. Bids shall be delivered duplicate to the address, District Secretary, District Secretariat, Ampara on or before **12.05.2026 at 10.00 hrs.** Late bids will be rejected. Bids will be opened soon after closing in the presence of the Bidders' representatives who choose to attend.
 6. Bids shall be valid up to **28.07.2026**. All bids shall be accompanied by a Bid Security, issued in favor of the District Secretary Ampara for an amount of Sri Lanka Rupees mentioned in Table, which should be obtained only from a reputed commercial bank operating in Sri Lanka, approved by the Central Bank of Sri Lanka OR Cash Payment may be made at the District Secretariat, Ampara. And valid up to **25.08.2026**
 7. The department Procurement Committee reserves the right to accept or reject any bid without providing a reason; its decision shall be final.
