2. Bidding will be conducted through the National Competitive Bidding (NCB) procedure.

3. Eligibility

3.1 To be eligible for the award of any of the above Contracts under **Package No. 01**, the Bidder shall not have been blacklisted and shall possess a **valid CIDA registration in the relevant grade(s) specified for the respective Contract**. In addition, the Bidder shall meet the following minimum qualification requirements:

- i. The average annual volume of building construction works performed during the last five years shall be at least **Rs. 150 million**.
- ii. The Bidder shall have completed at least one project of similar nature and complexity during the last five years.
- iii. A statement from an official banker of the Bidder confirming the availability of **credit facilities of 30% or above** for the relevant project shall be submitted.

3.2 To be eligible for contracts under Packages 02 and 03, supply bidders must possess valid Business Registration in the relevant field and/or be authorized sole agents, and must not have been blacklisted.

4. Bidders for contracts exceeding Rs. 5 million shall be registered with the Register of Public Contracts, Sri Lanka, in terms of the Public Contracts Act No. 3 of 1987, and shall submit a valid Certificate of Registration together with the bid.

5. Bids shall remain valid for 91 days for Packages 01 and 02 and 49 days for Package 03. Each bid shall be accompanied by a Bid Security as mentioned above.

6. Complete Procurement Documents for each Contract, in English, may be purchased by interested Bidders upon submission of a written application to the Chief Accountant, District Secretariat, Ampara, during the respective bid issuing period stated above, upon payment of the applicable non-refundable fee. Payment shall be made in cash.

7. Bids shall be delivered to the District Secretary, District Secretariat, Ampara, on or before the respective closing date and time stated above. Late bids will be rejected. Bids will be opened immediately after the closing time at the District Secretariat, Ampara, in the presence of the Bidders' representatives who choose to attend.

8. A pre-bid meeting will be held at **10.00 hrs. on 16.09.2026** at the District Secretariat, Ampara.

9. The decision of the Procurement Committee shall be final in respect of the award of the Contracts. In the event of any discrepancy between translations, the English version shall prevail.
