2. Bidding Procedure

Bidding will be conducted using the **National Competitive Bidding (NCB)** procedure in accordance with the applicable Government Procurement Guidelines of Sri Lanka.

- 3 To be eligible for the contract award, the successful Bidder shall not have been blacklisted and shall meet the following requirements,
 - i). Statement from official bankers of the Bidder regarding the availability of credit facilities liquid asset credit 30% of the bid value
 - i). Completion of one project of similar nature and complexity during the last five years.
- 4 All interested parties must be registered under Public Contract No. 3 of 1987 with the Department of the Registrar of Companies before collecting the Procurement Documents.

05. A complete set of Procurement Documents in English language may be purchased by interested Bidders on the submission of a written application to the **Chief Accountant, District Secretariat, Ampara from 01.09.2026- to 15.09.2026 from 09.00 hrs. To 15.00 hrs.** Upon payment of the applicable **non-refundable fee per package**, as specified in the above table. Payment shall be made in **cash only**.

6. Bids shall be delivered to the address below at. District Secretary, District Secretariat, Ampara on or before **16.09.2026 at 10.00 hrs.** Late bids will be rejected. Bids will be opened soon after closing in the presence of the Bidders' representatives who choose to attend.
7. Bids shall remain valid until **02.12.2026** and each bid shall be accompanied by a **Bid Security** as, mentioned above Bid Security shall remain valid until **30.12.2026**.

8. Award of Multiple Contracts

In the event that a single bidder is selected for all three works, the contractor shall be required to execute the works **simultaneously**, subject to the requirements specified in the respective contracts. Each work shall be treated as a **separate and distinct contract** and shall be governed by a separate agreement. The contractor shall complete each respective work within the contract period stipulated in its respective **Letter of Award and Contract Agreement**.

- 9 Procurement Committee's decision is the final on awarding contract and if any translation discrepancy, English is treated as the final one.
