

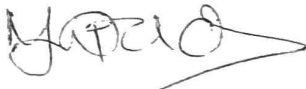

 - Minimum liquid assets/credit facilities must be at least 30% of the bid amount.
 - Bidders must demonstrate experience in at least one similar building project completed within the last three years.
- Interested Bidders may obtain further information from the **Chief Accountant, District Secretariat, Ampara** and inspect the Procurement Documents at the address given below from 9.00 hrs. to 15.00 hrs. on working days from **30.06.2026 to 13.07.2026**
 - A complete set of Procurement Documents in English language may be purchased by interested Bidders on the submission of a written application to the **Chief Accountant, District Secretariat, Ampara** from **30.06.2026 to 13.07.2026 from 09.00 hrs. to 15.00 hrs.** Upon payment of a non-refundable fee as mentioned above. The method of payment will be Cash.
 - Bids shall be delivered duplicate to the address, District Secretary, District Secretariat, Ampara on or before **14.07.2026 at 10.00 hrs.** Late bids will be rejected. Bids will be opened soon after closing in the presence of the Bidders' representatives who choose to attend.
 - Bids shall be valid up to **29.09.2026**. All bids shall be accompanied by a Bid Security, issued in favor of the District Secretary Ampara for an amount of Sri Lanka Rupees mentioned in Table, which should be obtained only from a reputed commercial bank operating in Sri Lanka, approved by the Central Bank of Sri Lanka OR Cash Payment may be made at the District Secretariat, Ampara. And valid up to **27.10.2026**
 - The department Procurement Committee reserves the right to accept or reject any bid without providing a reason; its decision shall be final.
