The **Chairman of the Department Procurement Committee**, District Secretariat, Ampara, on behalf of the **Ministry of Rural Development, Social Security and Community Empowerment**, invites sealed bids from eligible and qualified bidders for the supply and delivery of dairy cows to Community-Based Organizations under the **Prajashakthi – National Movement to Eradicate Poverty Programme – 2026**.

Bidders shall be eligible suppliers located in the Northern Province, Eastern Province, and the Districts of Kurunegala, Monaragala, Polonnaruwa, and Anuradhapura

01. Bidding will be conducted through National Competitive Bidding (NCB) method using the Single-Stage, Two-Envelope Bidding Procedure

02. Eligibility Requirements

Eligible bidders shall satisfy the following requirements:

- The bidders for the supply of items shall be legally registered to conduct livestock trading or dairy cattle supply in Sri Lanka & shall not be blacklisted
 - Have proven experience in supplying dairy cattle to Government institutions, NGOs, or private organizations.
 - Bidders for contracts exceeding Rs. 5 million shall be registered with the Register of Public Contracts, Sri Lanka, in terms of the Public Contracts Act No. 3 of 1987, and shall submit a valid Certificate of Registration together with the bid.
 - Other qualification stated in Procurement document
03. Interested eligible bidders may obtain further information from the **Chief Accountant, District Secretariat, Ampara**, and inspect the bidding documents at the address given below during office hours from **09:00 hrs. to 15:00 hrs. on working days from 06.08.2026 to 24.08.2026**.
4. A complete set of bidding documents in English may be purchased upon submission of a written application to the Chief Accountant, District Secretariat, Ampara, between **06.08.2026 to 24.08.2026.(09:00 hrs. – 15:00 hrs.)**, upon payment of a **non-refundable fee of Rs. 2,000.00 per supply package** (cash payment only).
 5. Bids shall remain valid until **13.10.2026** and **each** bid shall be accompanied by a **Bid Security** equivalent to **1% of the Bid Price (excluding VAT)**. The Bid Security shall remain valid until **10.11.2026**.

Bids shall be submitted in duplicate, with the **Technical Proposal** and **Financial Proposal** enclosed in separate sealed envelopes clearly marked "**Technical Proposal**" and "**Financial Proposal**", respectively. These two sealed envelopes shall be enclosed in a single outer sealed envelope clearly marked with the relevant Bid Number. The completed bid shall be delivered to the **District Secretary / Government Agent, Chairman, Department Procurement Committee, District Secretariat, Ampara**, on or before **25.08.2026 at 10:00 hrs**. Late bids will be rejected and authorized representatives who choose to attend.

04. Pre Bid meeting will be held on 17.08.2026 at 10.30am at district secretariat ampara
05. The decision of the Department Procurement Committee shall be final. The District Secretary reserves the right to accept or reject any bid, in whole or in part, without assigning any reason. The District Secretariat shall not be responsible for any costs or expenses incurred by bidders in the preparation or submission of their bids
